ACKNOWLEDGEMENT AND INDEMNITY

As a condition of hire of the Redlynch Equestrian Association (REA) grounds, I hereby acknowledge that I hire the grounds at my **OWN RISK** and that the Redlynch Equestrian Association Inc. accepts no responsibility or liability for any injury or loss that I or participants at the clinic/training day/event might sustain as a direct or indirect consequence of participation in activities at the REA grounds. On the basis of these conditions, I hereby indemnify the Redlynch Equestrian Association Inc. and its servants, agent, representatives or volunteers against all liability (including property damage) arising out of or in connection with participation to the fullest extent permitted by law but only to the extent that they are not already indemnified or insured.

I declare that participants, participants' horses and saddlery are in sound condition to participate in the activities to be undertaken.

I declare that:

- a) Insurance cover is in place – **copy forwarded to Redlynch Equestrian Association Inc.**

- b) Effective means of Emergency Services contacts are available / arranged.
- c) Facilities have been inspected and are safe to use.
- d) Rider(s) have been advised of potential hazards.
- e) Waivers (Indemnity) issued and signed.
- f) Emergency vehicle access is available.
- g) First Aid Kit(s) checked and adequate.
- h) Qualified First Aider(s) available.
- i) Access to roadways for uncontrolled horses has been contained.
- j) Separation of public parking, horses and spectators is in place.
- k) Control of areas where horses and the public use access ways, is in place.
- l) Arrangements for controlled access to horse areas have been made.
- m) Ratios of organizers to participants / spectators are appropriate.

I agree to:

- a) Immediately report to the Association any injury to myself, participants and/or horses and the manner of the occurrence of such injury.
- b) Ensure appropriate helmets (with EA tags where applicable) and riding boots are worn by participants.
- c) Be responsible for the well-being and safety of all participants, spectators, and horses.

I understand it is my responsibility to ensure the event adheres to government regulations regarding Covid19 regulations and Biosecurity Horse Health Declarations and will provide a representative of REA any information requested.

I certify that I am 18 years or older and I have read this document and fully understand it. I understand that my signature to this document constitutes a complete and unconditional release of all liability of the Redlynch Equestrian Association Inc. to the greatest extent allowed by law in the event of me, my organization and/or the participants under my care, suffering property damage, injury or death.
