## Agistment Application Terms and Conditions

---

1. I acknowledge that the REA may vary the agistment rates upon giving four weeks written notice
2. I acknowledge that the agistment fees are due and payable in advance every week on the Monday. Agistment cycle is from Monday to Sunday. It is encouraged that automated payment is set up through your banking system. The REA may charge a monthly accounting fee on overdue accounts.
3. I acknowledge that my horse/s must be fully vaccinated against Hendra virus, Tetanus and Strangles and that I will provide current receipts/vet certificates of vaccinations with the REA Agistment Application annually and/or upon request.
4. I acknowledge that the REA relies on the information provided by me and I state that all the information is accurate and complete.
5. I acknowledge that I agist my horse/s at the REA grounds at my own risk and that I am aware that activities involving horses can be hazardous and that the servants, agents, representatives or volunteers accept no responsibility or liability for any injury or loss that I or my horses/s might sustain as a direct or indirect consequence of agisting whether such injury is a consequence of any act or omission by the servants, agents, representatives or volunteers except in regard to any rights they may have arising relating to Australian Consumer Law in Queensland.
6. I agree that I will obey and will comply with all the REA rules and/or directions made or given by the REA in connection with the agisting of horses. I acknowledge that I have been advised to wear an approved helmet at all times while riding and appropriate footwear when handling and/or riding my horse/s.
7. I accept all risks associated with the agistment of my horse/s, including the possibility of injury, death, loss, or damage to myself and/or my horse/s
8. I agree to indemnify REA against all claims made by another person against the REA in respect of any injury, loss or damage suffered by myself, my horse/s or any person of their horse/s arising from or in

connection with my agisting/riding activities, whether such injury, loss or damage was caused directly or indirectly by any action of the REA.

9. I hereby release the REA from all such claims and indemnify the REA against all claims made by or on behalf of any other person.
10. I acknowledge that I must report all accidents, injuries, loss, or damage to the REA when I become aware of them.
11. If I suffer any injury or illness whilst at the REA grounds, I agree that the REA may provide evacuation, first aid and medical treatment at my expense, and my acceptance of these terms and conditions constitutes my consent to such evacuation, first aid or medical treatment.
12. If my horse suffers any injury or illness at the REA grounds and I am unable to be contacted, I agree that the REA may provide evacuation, first aid and medical treatment at my expense, and my acceptance of these terms and conditions constitutes my consent to such evacuation, first aid or medical treatment.
