## Agistment Application Terms & Conditions

1. I acknowledge that the REA may vary the agistment rates upon giving 4 weeks written notice.
2. I acknowledge that the agistment fees are due and payable in advance every five weeks within 14 days of receipt of the agistment invoice. The REA may charge a monthly accounting fee on overdue accounts.
3. I acknowledge that my agistment horse/s will be fully vaccinated against Hendra Virus, Tetanus & Strangles & I will provided current receipts/vet certificates of vaccinations with the REA Agistment Application each year and/or upon REA request.
4. I acknowledge that the REA relies on the information provided by me and I state that all the information is accurate and complete.
5. I acknowledge that agist my horse at the REP at my own risk and that I am aware that activities involving horses can be hazardous and that the servants, agents, representatives or volunteers accept no responsibility or liability for any injury or loss that I or my horse might sustain as a direct or indirect consequence of agisting whether such injury is a consequence of any act or omission by he servants agents representative or volunteers except in regard to any rights they may have arising under the Trade Practices Act 1974.
6. I agree that I will obey and will comply with all REA rules and/or directions made or given by the REA in connection with the agisting of horses. In particular I acknowledge that I have been advised to wear an approved helmet at all times whilst riding and appropriate footwear when handling and/or riding my horse.
7. I accept all risks associated with the agistment of my horse, including the possibility of injury, death, loss or damage to myself and/or my horse.
8. I agree to indemnify the REA against all claims made by another person against the REA in respect of any injury, loss or damage suffered by myself, my horse or any person or their horse arising from or in connection with my agisiting/ riding activities, whether such injury, loss or damage was caused directly or indirectly by any action of the REA.
9. I hereby release the REA from all such claims, and indemnify the REA against all claims made by or on behalf of any other person.
10. I acknowledge that I must report all accidents, injuries, loss or damage to the REA when I become aware of them.
11. If I suffer any injury or illness whilst at the REA, I agree that the REA may provide evacuation, first aid and medical treatment at my expense, and my acceptance of these terms and conditions constitutes my consent to such evacuation, first aid or medical treatment.
12. If my horse suffers any injury or illness at the REA and I am unable to be contacted, I agree that the REA may provide evacuation, first aid and medical treatment at my expense, and my acceptance of these terms and conditions constitutes my consent to such evacuation, first aid or medical treatment.
